FOR FACILITATING INDUSTRY-INSTITUTE INTERACTION THROUGH
FACULTY DEVELOPMENT, CONSULTANCY, CURRICULUM DESIGN, CONTENT
DEVELOPMENT, INTERNSHIPS AND CONTINUING EDUCATION PROGRAMMES

Excelsoft technologies Pvt. Ltd., Mysore and the JSS College of Arts, Commerce and Science, Ooty Road, Mysore-570 025 both the parties enter in the form of Memorandum of Understanding (MOU) with the mutual desire to promote cooperation between each other for the purpose of academic interaction in the field of consultancy, faculty development, curriculum design, content development, internships, skill development and other continuing education programmes.

Excel-Soft Technologies Pvt. Ltd., an STPI registered unit with CIN: and TIN: , offers value added products and services in e-Learning domain, that serve the interests of educational publishers, universities and schools as well as the government, defense and corporate sector.

JSS College of Arts, Commerce and Science, Ooty Road, Mysore started in 1964, is the first Degree College of JSS Mahavidyapeetha. The College is autonomous under University of Mysore and is re-accredited by NAAC with 'A' grade. It is identified by UGC as "College with Potential for Excellence", recognized by DBT, Govt. of India, New Delhi under "Star College Scheme".

Following are the terms of the agreement

1. Excelsoft technologies Pvt. Ltd. Mysore will facilitate the following:
 - a. Knowledge and Skill upgradation programs for the faculty members and the students via visits to Excelsoft facility and interaction with the key leadership team of Excelsoft
 - b. Providing inputs for curriculum development and encourage the faculty members to deliver industry relevant training programs to the students
 - c. Enable interactions between key technical professionals of Excelsoft and the Students via industry orientation programs held either in the college or in the Excelsoft campus
 - d. Provide inputs to the students in the areas of leadership development and entrepreneurship
 - e. Explore possibilities of providing on-the-job training opportunities and internships for students in relevant areas



- f. Design short duration continuing education programmes to the faculty and students
2. The JSS College of Arts, Commerce and Science, Ooty Road, Mysore will facilitate the following:
 - a. The College will encourage the faculty members and the students to participate in the skill development and continuing education programmes,
 - b. The College will send students for interactions with professionals and to engage in on-the-job training
3. Any commercial arrangement for any of the programmes or activities will be mutually agreed upon.
4. Each party acknowledges that information of a confidential nature relating to the business of the other may be disclosed to it under this MOU. Each party undertakes to hold such information in confidence and not, without the consent of the other, disclose it to any Third Party nor use it for any purpose other than in the performance of this MOU. This confidentiality will be binding for as long as such information retains commercial value and shall does not reach the public domain.
5. All documents and other tangible objects containing or representing Confidential & Business Information which have been disclosed to a Receiving Party by the Disclosing Party during the trial period, and all copies, excerpts and summaries thereof shall be and remain the property of the Disclosing Party and shall be promptly returned to the Disclosing Party or destroyed at the expiry/end of the trial period.
6. The obligation of confidentiality will not apply to information that is generally known to the public through no act or omission of the receiving party or becomes known to the receiving party through a third party with no obligation of confidentiality or is required to be disclosed by law, court order or request by any government or regulatory authority.
7. No public announcement, press release, communication or circular (other than to the extent required by law or regulation) concerning this MOU shall be made or sent by either party without the prior consent of the other. However, such consent shall not be unreasonably withheld.
8. This agreement will be in effect initially for a period 5 years from the date of signing of this MOU by both the parties, renewable further if mutually agreed. Either party may terminate the agreement by written notification signed by the appropriate party six month prior to the effective termination date. However, obligations and commitments already contracted for and involving their parties shall be honored and continue by both parties until such commitments are completed.



9. Nothing herein shall grant a party any right, title, or interest in the other party's trademarks, trade names and other intellectual property rights in the other party's product, other than to the extent of purposes as contemplated herein.
10. This MOU shall not be varied, amended or modified by any of the Parties in any manner whatsoever unless such variation, amendment or modification is mutually discussed & agreed to in writing and duly executed by both the Parties.
11. This MOU may be executed in two or more counterparts, each of which, when executed and delivered, is an original, but two all the counterparts taken together shall constitute one document.


